# Program Eligibility

## All Program Locations:

- ◆ D.C. & Austin applicants must be United States citizens.
- ◆ GPR requirements:  
D.C. & Rome programs: 2.5 cumulative GPR (*2.25 allowed with additional letter of recommendation*)  
Austin program: 2.5 cumulative GPR
- ◆ Be a currently enrolled degree-seeking student (undergraduate, graduate, doctoral) in good-standing in the College of Agriculture & Life Sciences at Texas A&M.
- ◆ Possess valid health insurance during the internship semester
- ◆ Must be able to attend all pre-departure trainings & events in College Station

## Rome Program:

- ◆ Open to United States citizens, permanent residents, and international students that are able to travel legally from and to the United States.
- ◆ Must possess a valid U.S. passport that does not expire within six (6) months of the end of the internship semester
- ◆ Must possess CISI health & travel insurance, available through the Study Abroad Programs Office
- ◆ Must obtain a visa prior to departure if the internship will last more than 90 days

## Miscellaneous:

- ◆ Undergraduates may participate in the domestic programs (D.C. & Austin) during the long semester after they graduate.
- ◆ Austin interns are expected to serve the entire length of the Texas Legislative session (early January through early June), which exceeds the A&M spring semester.
